### Privacy Policy

The Film Society of Lincoln Center, Inc. ("The Film Society of Lincoln Center") knows that users of its web site care about the personal information they provide to us. This privacy policy, which is part of our overall [Terms and Conditions of Use](#), is designed to provide you with information about how we collect, store and use personally identifiable information obtained through our web site. We refer to this information as "personal information." The Film Society of Lincoln Center reserves the right to revise this privacy policy from time to time, and by using the The Film Society of Lincoln Center web site, you are agreeing to the terms of the then current privacy policy.

#### **How Information Is Collected.**

When you register at The Film Society of Lincoln Center to utilize certain of our web site services, we will ask you for information such as your name, address, e-mail address, telephone number, certain demographic information and (if needed) credit card information. We need certain information in order to register you as a unique user and let you access personalized services. However, other requested information is optional and can be given at your discretion.

Like most web sites, The Film Society of Lincoln Center uses "cookies." A "cookie" is a text file, invoked by standard browser software, that we place on your hard drive to enable our systems to recognize your browser, track transactions, and allow you to navigate our web site without having to re-enter information. The information gathered by cookies is not made available to any unaffiliated organizations. We may also automatically receive and store certain other types of information, such as the type of web browser you use or the pages you link to from the The Film Society of Lincoln Center web site.

#### **Use of Information We Collect.**

Personal information collected through this web site may be used by The Film Society of Lincoln Center to communicate with you, register you as a user, allow purchasing and shipping of tickets, subscriptions, memberships and/or merchandise, enable you to participate in special promotions and to navigate areas of our the web site without having to re-enter information. Such information may also be used to administer our web site, in compliance with applicable law, and as otherwise stated in this privacy policy. We may occasionally make some personal information available to select other organizations, including but not limited to, non-profit arts organizations, affiliated organizations, agents working on our behalf, companies or organizations with whom we have a contractual or sponsor relationship, or in connection with an asset transfer. Such information

would be limited to names, and email addresses. We may also provide aggregated data to these and other organizations.

Certain of our programs use personal information to send updates and notices to registered users via e-mail. If you provide your mailing address or telephone number, The Film Society of Lincoln Center may also use your personal information to contact you by mail or by telephone regarding special offers from The Film Society of Lincoln Center, updated information about The Film Society of Lincoln Center or the The Film Society of Lincoln Center web site, and new services offered by The Film Society of Lincoln Center. We also may disclose your personal information if we believe in good faith that we are required to do so in order to comply with applicable law, a subpoena, or other legal process.

### **Security Used To Protect Your Information.**

We store all user information in secure databases protected via a variety of access controls, including password protection, electronic firewalls, and data encryption.
